Requesting an urgent temporary measures,
temporary provision of accommodation or
hand over of shelter from a police officer

investigation

It is treated as a general criminal case
or a family protection case

domestic violence punishment regulations



Article 257
of the criminal code

injury to a spouse or child

The law sets a penalty of up to seven years in prison
or a fine of up to ten million won

Article 283
of the criminal code

threat to a spouse or child

The law sets a penalty of up to three years in prison
or a fine of up to five million won

Article 260
of the criminal code

assault on a spouse or child

The law sets a penalty of up to two years in prison or a fine
of up to five million won

Article 273
of the criminal code

abuse of a spouse or child

The law sets a penalty of up to two years in prison or a fine
of up to five million won





child abuse NO!

What is child abuse?



Child abuse means that adults, including guardians harm the health or welfare of children and physical, mental, sexual violence that cause impediment normal development





child abuse NO!

Type of child abuse

1

physical abuse

the act of inflicting physical damage



emotional abuse

emotional violence or cruel treatment

sexual abuse

all sexual acts for the purpose of satisfaction of sexual desires

neglect

the act of not providing food, clothing and shelter, education, medical care etc



child abuse NO!

punishment for child abuse?

- ① In the case of death caused by an act of injury, assault, abandonment, etc
life imprisonment or up to 5 years in prison



- ② If the life risk occurs or lead to incurable disease and disabled
up to 3 years in prison
